

The services we offer if you don't have an adviser

If your relationship with your adviser has come to an end, we're more than happy to continue to help you and administer your existing investments, in line with our terms and conditions.

You won't have access to the full range of services that an adviser could perform on your behalf, so we've put together this guide to show you what we can offer.

This table shows the services available:

** Due to potential tax implications, withdrawals and full surrenders on Onshore and Offshore Bonds should be completed on an advised basis. However, we can review non-advised requests on a case-by-case basis.

What if I have an adviser who doesn't use the Nucleus platform?

If we don't have a relationship with your adviser, you're limited to the services shown in the table. However, if you've given us details of a Financial Services Authority (FCA) authorised firm to act on your behalf, we'll be able to provide them with details of your account – this is called an "information only" service.

We can't pay fees to your new adviser if they don't have access to our platform.

How can I keep track of my investments?



You can access [Nucleus Go](#) to securely view all your investments online at any time. You can see money paid in, withdrawals, fund switches, valuations and performance analysis as well as any correspondence about your accounts.

It's important that you keep up to date with the correspondence we produce for you as it may help the financial decisions you make in the future. If you don't sign up to [Go](#), we'll have to send all your correspondence in the post.

Corporate actions on your investments

A corporate action is when a market event affects any of the assets you've invested in.

We won't send the market notification to you or give you any election options offered via the notification. Where a decision is required the default option will always take effect. We'll simply update your account when the corporate action activity is complete.

What instructions will you accept from me?

When we receive clear instructions from you, and once we've verified that they're genuine, we'll carry out:

- your instructions, shown in the table
- any account updates e.g. changes to your address, your bank details or requests for online access
- the appointment of a new adviser (who uses our platform) or a request to give an adviser 'information only access' to your account(s).

Any trade instruction for a top up, withdrawal or transfer will be carried out on a non-advised basis.

If you wish to place an investment into a new asset (one you don't currently hold) we'll send you a pre-sales illustration and a 'Key Investor Information Document'. Please read these documents carefully as we'll need you to complete additional validation before we can place the trade(s).

What happens if I progress on a non-advised basis?

We must remind you that progressing on a non-advised basis may affect the regulatory protection you would otherwise be entitled to. For example, you will not have recourse against an adviser firm in regard to investment decisions made by you. Your right to pursue compensation via the Financial Services Compensation Scheme is not affected when we execute a transaction for you on a non-advised basis.

Standardised investment option for a non-advised pension customer

If you aren't following financial advice about your investment choices and don't wish to select your own investments, one option that's available to you is a range of target retirement funds. We've identified them as being suitable to meet the needs of a typical non-advised pension customer. If you'd like information about these funds please contact us.

You should know that they're ready-made portfolios, aligned to a preset range of retirement dates, and aren't tailored to an individual's retirement goals.

Please note that these funds are managed by Vanguard and their inclusion on our platform doesn't mean we endorse or recommend them. If your investment needs and objectives fall outside of this standardised option, you might want to consider other investment choices.

If you want to ensure that your investment choices are suitable for your financial goals, we strongly suggest that you engage with an adviser.
