Data protection

The purpose of this form is to collect information which RL360 requires in order to provide your Offshore Bond and associated services. RL360 will be a controller of the personal data collected in connection with your Offshore Bond and is responsible for its processing. It will process your personal data in accordance with its privacy policy.

You may ask RL360 to stop processing your data, however this may disrupt the services RL360 can provide to you or may stop it being able to assist you. To find out how long RL360 will keep your data, please refer to its privacy policy.

Any data you provide to RL360 may be shared, if permitted by law, with other companies both inside and outside of the RL360 Group and to persons who act on your behalf. Data and information about you can be transferred outside of the Isle of Man and RL360 may be required to provide it to its regulator, the government or anyone else required by law.

RL360 will use your data and information in administering and operating your Offshore Bond, in carrying out checks to prevent financial crime, to exercise legal rights and comply with law, and otherwise in fulfilling the RL360 Group's legitimate interests and as further set out in its privacy policy.

RL360 will, at all times, make sure that your data and information is only used in ways that are permitted by law.

You can receive a copy of the information RL360 holds about you free of charge by writing to its Data Protection Officer using the details set out above.

RL360 can choose to not send you your personal data in some circumstances (for example if it reasonably considers your request is excessive). If it does, it will write to you setting out the reasons why.
