- **Key Investor Information Document (KIID)** or **Key Information Document (KID)** for UCITS funds (Undertakings for Collective Investment Transferable Securities), or
- **Simplified Prospectus** for other funds, where available.

These documents are available from the investment provider directly.

### Transmission

A copy of our **Order Execution Policy** is available on our website. This sets out our policy on receiving and transmitting trading instructions.

### Aggregated costs and charges

It's a regulatory requirement that you are provided with the aggregated costs and charges of making this investment before proceeding. This includes the investment provider's charges, our charges for making the investment, and any adviser charges. You will be asked to confirm this later in this document.

Your adviser should obtain and provide this aggregated information as part of their service to you. If you do not have an adviser, you can call us with details of the charges you obtain from the investment provider and we will put these, along with our charges, into our calculator and provide this disclosure to you.

## Target market
