- When returning this document to client relations, please make sure the anti-money laundering documents in respect of each assignee (unless already a Nucleus platform client), the Bond Declaration completed by each assignee (if not already the holder of the bond) and the reason for the assignment are also enclosed. HMRC rules, introduced from 1 September 2022, require us to obtain proof that the trust is registered with the Trustee Registration Service (TRS). As there has been a change of trustee, the register will need to be updated within 90 days of the event. Nucleus will therefore require sight of the amendments, and a revised Proof of Registration document should be supplied.
